## **Undergraduate Medical Education (UME)**

Since 2009, Genesis Medicus Clinical Campus (GM-CC) has been a driving force in implementing (UME) clinical rotation programs for 3<sup>rd</sup> and 4<sup>th</sup> year international medical students. This program provides implementation and management services for new and existing ACGME or AOA accredited programs for Undergraduate Medical Education (UME).

The GM Clinical Campus model offers students the ability to complete all 3rd year Cores and 4th year Electives and Sub-I's in a single geographic location and often at a single-site. The Genesis Medicus model enhances the experience for learners. As such it offers our client schools a clinical campus which acts as an extension of the schools stateside.

Our clinical campus model offers a comprehensive program providing student clerkship rotations in all the required subject cores: Family Medicine, Pediatrics, Obstetrics and Gynecology, General Surgery, Internal Medicine, and Psychiatry. Based on the breadth of our offering, international schools of medicine (ISOM) have entrusted our program to secure new affiliations and sites that we manage on their behalf.

Our preceptor model offers students high quality, personalized mentoring under the leadership of our proprietary Teaching Faculty Network (TFN). The program has proven to deliver impressive USMLE pass rates, an accomplished network of alumni, and strong partnerships with residency placement sites across the United States.

- The school's curriculum is equivalent to that of U.S. medical schools. Upon completion of the required science courses in the 1st two years, students will complete 3rd and 4th years, learning clinical skills at affiliated teaching hospitals and other clinical sites in the United States.
- The program includes a strong research component in which students participate in several projects with attendings, residents, and fellows on subjects ranging from Asthma to Pharmacogenetics, etc.
- All students are eligible to sit for the (USMLE) United States Medical Licensing Examination and if qualified, obtain residency.
- GMCC Clients are accredited by the National Committee on Foreign Medical Education and Accreditation (NCFMEA, DOE), Accreditation Commission on Colleges of Medicine (ACCM), Nederlands-Vlaamse Accreditatie Organisati (NVAO) Caribbean Accreditation Authority for Education in Medicine and other Health Professions (CAAM-HP) and the Grenada Medical and Dental Council (GMDC).
- We also engage our GME Affiliates to ensure that there is additional monitoring to ensure quality and established practices like those followed by domestic medical schools.

## **Clinical Training**

All students have the option to choose between clinical sites available in the United States. It is during their clinical rotations in which students apply their medical science coursework knowledge and experience, and will likely discover the area of medicine in which they are most passionate.



## An Overview...

Once students have completed their 1st and 2nd year of basic science coursework, and passed their USMLE Step 1 exam, they then begin their 3rd and 4th year of medical education in which they undergo a series of clinical rotations within our program. The program is 72-weeks in length and clerkships will be scheduled at one or more hospitals throughout our affiliate and accredited teaching affiliates, or teaching hospital system networks across the United States.

Clinical clerkships are divided into Core Rotations and Elective/Sub-I's Rotations. Core rotations are the foundation of a student's clinical education. Elective rotations are medical sub-specialties under each of the main Core Rotations in which students choose their objectives according to their preferred area of anticipated postgraduate residency training.

(\*) In some states Family Medicine is a required subject core, allowing for students to conduct all their rotation under the FM umbrella if the preceptor-ship remains core specific.

## Preparation...

The Introduction to Clinical Medicine (ICM) is a course in which all students participate during their second through fifth semester in Medical Sciences. This course will engender the clinical skills necessary for clinical clerkships and professional development. Students are equipped with the knowledge and skills to perform the following:

- Complete histories and conduct physical examinations
- Formulate an assessment and plan for the care of patients
- Conduct library and computer search of relevant information for patient care
- Commit to active participation in research projects along side fellows and residents

Students are introduced to the clinical medical information necessary for their 3rd and 4th year rotations. This will be done in a problem-based learning format, stressing a review of the medical sciences, the development of case-centered learning goals, and the introduction of a series of core medical conditions. In addition, Behavioral Medicine will be fully integrated into the courses, as well as weekly didactics and simulation sessions which focus on teaching and developing required Clinical Knowledge (CK), which are key components for the USMLE Step 2 Exam.

## **CLINICAL CORE ROTATIONS**

Clinical core rotations are full-time clerkships completed within 42 to 48 weeks (depending on the state and school) whereby students evaluate patients in a clinical setting. Students have the opportunity to utilize skills and information previously acquired in the medical sciences and ICM courses. As active team members of the student and house staff, all students are supervised by attending physicians as they evaluate laboratory data, diagnose patients, and discuss treatment options.



## Each student's clinical supervisor evaluates the student's performance according to standards set by the schools.

\*Students are covered by the school's Professional Liability (malpractice insurance) for the duration of their rotation. Each affiliate teaching site is issued a certificate of insurance deeming students, clinical sites, and faculties as additional insured.

- Surgery (12 weeks)
- Pediatrics (6 weeks)
- Obstetrics and Gynecology (6 weeks)
- Psychiatry (6 weeks)

## **ELECTIVE ROTATIONS**

Elective Rotations are an integral part of the student's clinical experience to which students are exposed to an array of specialties to consider for their future medical careers. Students complete 36-weeks of electives, including the optional, yet highly recommended, 4-weeks of Neurology, and 4-weeks of Family Medicine.



## **OVERVIEW**

## What is Medical Simulation Training?

Medical simulation training, simply put, replicates in-vivo cases in an in-vitro environment which includes training of life and death situations to produce the best outcome in real-life situations. Genesis Medicus-CC has partnered with Gaumard Scientific to provide training and practice for fledgling health professionals in gaining competency and confidence in working with real-life patients by practicing and working with responsive and dynamic simulation patients though the use of various bionic simulation models.

Specifically, medical simulation focuses on training objectives such as learning how to diagnose, treat, perform surgery and labor and delivery. Further, medical simulations may employ one or several of these elements to develop and deliver situationally appropriate training.

Diagnosing Illness: Before knowing how to treat an illness, a physician must first become aware of how to make a proper diagnosis. This includes a thorough patient assessment (obtain a proper history and physical), a strong understanding of all possible pathological options, deductive reasoning, and a determination of additional knowledge needed to make a diagnosis.

Prescribing Treatments: Learning how to prescribe appropriate treatments requires an understanding of pharmacology, non-pharmacological therapies, surgical options, illness subtypes, changes in the world of research, and what is most appropriate given the patient's socioeconomic status. Medical simulation can be used under these circumstances to give the physician the opportunity to treat a patient, then show the result of whatever regimen was chosen.

Surgical Procedures/ Labor and Delivery: Since these procedures typically involve an elevated level of risk, surgeons often experience many simulated surgeries before ever performing a real one. This allows the provider to practice the simultaneous management of sterile procedure, precise technique, proficiency with various instruments, and collaborating with the surgical team. In surgery, there is no replacement for practice, so surgical simulation is a great way to obtain experience in a manner that does not risk harming patients.


